Your directors have pleasure in presenting the 56th Annual Report with audited accounts for the year ended 31st March 2009. The summarised financial results of the Company are given hereunder:





#### **DIVIDEND**

Your Company paid a tax-free interim dividend of Rs.4/- per share (40% on the face value of Rs.10/-) on 18th March 2009. Your directors are now pleased to recommend a final dividend of Rs.2.50 per share (25% on the face value of Rs.10/-). This, together with the interim dividend, aggregates to a total dividend of Rs.6.50 per



share (65%) for the financial year ended 31st March 2009, on the paid-up capital of Rs. 55.55 cr., doubled as a result of bonus issue in the ratio of 1:1.

#### MANAGEMENT DISCUSSION AND ANALYSIS

#### **OVERVIEW**


Financial markets the world over look very different today from what they did a year ago. The cataclysmic events that shook the very foundations of the American financial system and subsequently the rest of the world have already been acknowledged as the worst financial crisis since the Great Depression. Several banks and financial institutions of great repute have gone into bankruptcy while many more have barely survived, thanks to financial lifelines thrown to them by their Governments. In Europe, whole countries have gone bankrupt or come dangerously close to it. In the aftermath of this unprecedented financial and economic meltdown, most of the world's major economies are faced with the spectre of zero growth, or worse still, negative growth. While India stands on a relatively better footing, thanks to regulatory prudence and foresight, it is by no means unaffected by the tumultuous events that overtook the global financial markets. The pain for India has been more in the Real Economy, with sector after sector experiencing steep contractions in demand. Current estimates put GDP growth at 6.7% during 2008-09 as against 9% achieved during each of the three years ending 2007-08. The agricultural, industrial and services sectors are estimated to have grown at 2.6%, 4.8% and 9.6% respectively, as against 4.5%, 8.1% and 10.9% in the previous year. The Indian financial markets witnessed significant volatility during the third quarter of the year resulting in liquidity strain and high interest rates. RBI's continuous and effective interventions helped restore stability and infuse confidence in the financial system. Inflation, as measured by Wholesale Price Index, touched a high of 12.91% in August 2008, on account of the sharp rise in global commodity and fuel prices, but has since swung the other way to touch a low of 0.26% during March 2009, as compared to 7.75% during the same period last year.

The country's balance of payments position came under some strain during the year. Exports are estimated to have increased by 7.3% in dollar terms, while imports grew by 19.1%. India's foreign exchange reserves, at US\$ 241.7 billion, decreased by US\$58 billion during 2008-09. With the US Dollar strengthening against all major currencies, the Indian Rupee ended lower by 27% at the end of the year 2008-09. The central government's fiscal deficit has been estimated at 5.93% of GDP as against 3.10% of GDP in the previous year.


#### **AUTOMOTIVE SECTOR**

The automotive industry in India was amongst the worst hit sectors of the economy. Sales of medium and heavy commercial vehicles (M&HCV) registered a steep fall of 33% during 2008-09 as against a drop of 2% in the previous year. Sales of light commercial vehicles (LCV) were also down by 7% during 2008-09 as against a growth of 12% in the previous year. Sales of cars and multi-utility vehicles recorded a marginal growth during 2008-09 as against a growth of 12% in the previous year. The haulage segment bore the brunt of the fall in the M&HCV class with sales of multi axle trucks falling by 40% and Tractor-Trailers falling by as much as 61%. In many ways, this does not come as a surprise. Over the past several years, cheap availability of finance and indiscriminate lending practices had led to the build up of excess capacity in the haulage segment. With the economy slowing down, freight offerings have fallen

significantly, impacting not only new vehicle demand but also the viability of existing fleets. This correction was not only overdue but also desirable in some respects. Passenger car sales, on the other hand, were affected by concerns surrounding employment stability, risk aversion on the part of lenders and a certain degree of debt aversion on the part of prospective buyers.


#### **OPERATING & FINANCIAL PERFORMANCE**

Reflecting the trends in the automotive sector, your Company's hire purchase and loan disbursements at Rs.4540 cr. were lower by 11.14% as compared to the previous year. Sale of commercial vehicles fell by 26% in unit terms. However, your Company improved its market share in most of its key markets. Foreseeing the slump in the commercial vehicle segment, your Company had focussed its efforts on cars and multi-utility vehicles. Consequently, your Company registered a growth of 23% in unit terms over the previous year in this segment and improved its All India market share in the process. The gross receivables being managed by the Company, including assets sold or securitised, stood at Rs.9203 cr. as at 31st March 2009, as against Rs.8925 cr. in the previous year.

A high quality asset portfolio remains at the core of your Company's operations, thanks to our unswerving focus on the credit assessment process and continuous vigil on timely recoveries. Gross NPAs as at 31st March, 2009 stood at 1.64% as against 1.18% in the previous year and Net NPAs at 0.75% as against 0.49% in the previous year.

Even by the most stringent yardsticks, this would count amongst the best in the business, especially in light of the turmoil in the markets.

Gross income from hire purchase, hypothecation loans and leasing grew by 20% over last year. The volatile liquidity and heightened uncertainty in the financial markets notwithstanding, your Company was able to sustain its margins on account of its prudent Asset-Liability Management, strict credit underwriting, consistent presence in the market and its ability to deliver a superior customer experience. Several quality and process improvement measures have been undertaken by your Company during the year. These, combined with a heightened level of cost awareness have enabled your Company to keep a tight rein on costs.

The net profit for the year was Rs. 150.73 cr. as against Rs.135.73 cr. (excluding the one-time profit on the sale of shares in Sundaram Home Finance Limited) in the previous year, registering a growth of 11.06%. The Company's Net-Worth stood at Rs. 1153 cr. as on 31.3.2009, while Capital Adequacy (CRAR) at 14.65% was comfortably higher than the statutory requirement of 12%.

#### RESOURCE MOBILISATION

#### a) Deposits

During 2008-09, your Company mobilised fresh deposits aggregating to Rs.257.76 cr. Renewal of deposits matured during the year amounted to Rs.215.28 cr. representing 81% of the matured deposits. Deposits outstanding at the year-end were at Rs.940.06 cr.

as against Rs.756.62 cr. in the previous year, recording the highest annual net accretion in the history of your Company.

As at 31st March 2009, 3079 deposits amounting to Rs.7.63 cr., had matured for payment and were due to be claimed or renewed. After close follow-up of repayments or renewals, the figures are currently down to 1821 and Rs.3.98 cr. respectively. Steps are continuously being taken to arrange for repayment or renewal of these deposits. Investor Relation Services - Deposits continue to enjoy the ISO 9001:2000 certification by Bureau Veritas Certification (India) Private Limited.

#### b) Term Funding

During the year, your Company raised term funding in the form of non-convertible debentures and term loans to the tune of Rs.2341 cr., across various tenors.

#### c) Bank Finance

Your Company's bankers continue to extend their support, providing loans at competitive rates. Your Company issued several tranches of commercial paper aggregating to Rs.1765 cr., during the year. The maximum amount outstanding at any time was Rs.1185 cr., and the amount outstanding at the end of the year was Rs.490 cr. The working capital credit limits of your Company were increased from Rs.1650 cr. to Rs.1800 cr.

#### d) Sell-down of Receivables

During the year, your Company sold hire purchase and hypothecation loan receivables to the extent of Rs. 769.87 cr.

#### **CREDIT RATINGS**

All the borrowings of the Company are rated. The short term borrowings (including commercial papers) are rated "A1+/P1+/F1+" (highest safety).

Fixed Deposits are rated "AAA" (highest safety). The long term borrowings are rated "AA+" (high safety). The long term ratings have a "Stable outlook" from ICRA and FITCH and "Negative outlook" from CRISIL.

#### **BUSINESS OUTLOOK**

Pronouncements by several leading economists and Central Bankers across the world would suggest that the worst is over for the global economy. There are early, if feeble, signs of recovery in the US economy, which has a significant bearing on the other major economies including India. The formation of a stable government at the Centre brings with it the hope of a renewed thrust on economic reforms and the pursuit of a growth agenda which are critical prerequisites for the Indian Economy to regain its growth momentum.

Even though headline inflation has been brought under control, the projected increase in government borrowings is likely to have an adverse impact on market liquidity and consequently, on interest rates. As indicated in last year's report, the prospects for the automotive sector are unlikely to improve dramatically in the coming year with concerns around viability of commercial vehicle operations continuing and passenger car manufacturers themselves projecting only modest growth. Your Company, as in the past, will continue to pursue its objective of Growth with Quality. Your Company also continues to focus on new opportunities to improve profitability.

#### INTERNAL AUDIT

As part of the effort to evaluate the effectiveness of the internal control systems, your Company's internal audit department reviews all the control measures on a periodic basis and recommends improvements, wherever appropriate. The internal audit department reports directly to the Audit Committee of the Board. The Audit Committee regularly reviews the audit findings as well as the adequacy and effectiveness of the internal control measures. Additionally, an Information Security Assurance Service is also provided by independent external professionals. Based on their recommendations, the Company has implemented a number of control measures both in operational and accounting related areas, apart from security related measures.

#### RISK MANAGEMENT

Your Company continues to follow the time tested practice of assessing each and every borrower before committing to a credit exposure. This process ensures that the expertise in lending operations acquired by the Company over decades is put to best use and acts to mitigate credit risks. The extensive knowledge sharing of current market trends across the Company facilitates course corrections wherever necessary. Periodic monitoring and reviews by the asset liability management committee and risk management committee enable the Company to function within the risk management framework.

#### **HUMAN RESOURCES**

Your Company continues to lay great stress on its most valuable resource - people. Continuous training, both on the job and in an academic setting, is a critical input to ensure that employees at all levels are fully equipped to deliver a wide variety of products and services to the rapidly growing customer base of your Company. In spite of the difficult business environment, your Company has undertaken a number of training initiatives during the year covering junior and middle level managers, as well as Leadership Development Programmes for those in senior management roles.

#### CONSOLIDATED FINANCIAL STATEMENTS

The Consolidated Financial Statements, drawn up in accordance with the applicable Accounting Standards, form part of the Annual Report.

In view of this and in accordance with the approval granted by the Central Government under Section 212(8) of the Companies Act, 1956, the Balance Sheet, Profit and Loss Account, Report of the Board of Directors and Report of the Auditors of the Subsidiary Companies, have not been attached to the Balance Sheet of your Company. The financial information relating to all the Subsidiary Companies, in the aggregate, has been disclosed in the Consolidated Financial Statements, as required by the Central Government as part of its approval. Further,

#### **SUBSIDIARIES**

#### • Sundaram BNP Paribas Home Finance Limited

Despite the economic downturn during the second half of 2008-09 which weakened the demand for housing finance, the company, in its tenth year of operation, approved loans aggregating Rs.600 cr. as against Rs.721 cr. in the previous year; disbursements amounted to Rs. 532 cr. as against Rs.596 cr. in the previous year. The company earned a gross income



of Rs.208 cr. as against Rs.160 cr. in the previous year and reported a profit after tax of Rs.26.81 cr. as against Rs.22.10 cr. in the previous year. The loan portfolio as at 31st March 2009 stood at Rs.1592 cr. as against Rs.1433 cr. in the previous year. The gross and net NPAs stood at 0.30% and 0.10% respectively as of 31.03.09. The company recommended a maiden dividend of Re.1 per share (10% on the face value of Rs.10/-) for the financial year ended 31st March 2009.

#### Sundaram BNP Paribas Asset Management Company Limited

2008-09 was a difficult year for the mutual fund industry which saw a reversal of trend from the previous year due to a steep correction in equity markets. The Average Assets under Management (AUM) of Sundaram BNP Paribas Asset Management Company Ltd. was Rs.9267 cr. for the year 2008-09, lower by 28% as compared to Rs.12827 cr. for the previous year, due to steep correction in the equity market. In the face of the industry trend of outflows and negative average growth, the investor base of Sundaram BNP Paribas Asset Management Company Limited has risen from 2 million to 2.25 million during the year indicating rising retail participation and confidence. Consequent to their continued endeavour to enhance fund management skills and optimise performance levels, the schemes of Sundaram BNP Paribas Mutual Fund received many awards from various agencies.

Sundaram BNP Paribas Asset Management Company Limited earned a gross income of Rs.86.05 cr. as against Rs.85.18 cr. in the previous year. After providing for depreciation and tax, the company reported a profit of Rs. 10.68 cr. as against Rs. 18.50 cr. in the previous year. The company recommended a dividend of Rs.1.50 per share (15% on the face value of Rs.10/-) for the financial year ended 31st March 2009.

#### Sundaram BNP Paribas Trustee Company Limited

Sundaram BNP Paribas Trustee Company Limited earned a gross income of Rs. 105.39 lakhs as against Rs. 102.21 lakhs in the previous year and reported a profit after tax of Rs. 36.44 lakhs for the year, as against Rs.33.51 lakhs in the previous year. The company recommended a higher dividend of Rs.50/- per share (500% on the face value of Rs.10/-) for the financial year ended 31st March 2009.

#### • Sundaram Finance Distribution Limited (SFDL)

Due to the decline in New Fund Offers (NFOs) by mutual funds consequent to tightening liquidity and slowdown in stock markets. SFDL's income through distribution of various mutual fund and financial products was lower at Rs.104.46 lakhs as against Rs.281.58 lakhs in the previous year. However, despite reduction in insurance premium levels consequent to detariffing, SFDL earned a higher commission of Rs.228.27 lakhs through stepped-up efforts in distribution of insurance products during the year as against Rs. 82.38 lakhs in the previous year. The profit after tax for the year amounted to Rs.137.08 lakhs as against Rs.167.82 lakhs in the previous year. The company declared, on 03.03.2009, an interim dividend of Rs. 10/- per share (100% on the face value of Rs.10/-) for the financial year ended 31st March 2009. The company also recommended a final dividend of Rs.10/- per share (100% on the face value of Rs.10/-) for the financial vear ended 31st March 2009.

#### • LGF Services Limited

Despite reduction in insurance premium levels consequent to detariffing, LGF Services Limited, in its fifth year of operation, earned a higher commission of Rs.438.04 lakhs through stepped-up efforts in the distribution of insurance products as against Rs. 385.75 lakhs in the previous year. The profit after tax for the year was higher at Rs.177.33 lakhs as against Rs.143.88 lakhs in the previous year. The company declared, on 03.03.2009, an interim dividend of Rs.30/- per share (300% on the face value of Rs.10/-) for the financial year ended 31st March 2009. The company also recommended a final dividend of Rs.15/- per share (150% on the face value of Rs.10/-) for the financial year ended 31st March 2009.

#### Sundaram Infotech Solutions Limited (SISL)

The company earned a gross income of Rs.906.03 lakhs, as against Rs.871.29 lakhs in the previous year. Inspite of challenging times for the information technology industry, SISL was able to win some new contracts. However, it expects significant delays in finalising pending transactions with prospective customers.

#### • Sundaram Business Services Limited (SBSL)

SBSL earned a gross income of Rs.1649.12 lakhs for the year ended 31.03.2009 and reported a profit after tax of Rs.38.58 lakhs as against Rs.16.48 lakhs in the previous year. During the year, SBSL increased its stake in Professional Management Consultants Private Limited (PMC) from 74% to 87%. In May 2009, PMC became a wholly-owned subsidiary of SBSL consequent to acquisition of the balance 13%.

## Professional Management Consultants Private Limited (PMC)

During the year, PMC earned a gross income of Rs.886.38 lakhs as against Rs.876.88 lakhs in the previous year. The company reported a profit after tax of Rs.68.92 lakhs as against Rs.92.59 lakhs in the previous year.

#### • Infreight Logistics Solutions Limited (Infreight)

During the year, Infreight earned a gross income of Rs.3063.29 lakhs as against Rs.3025.77 lakhs in the previous year. The company's growth plans have been affected by the general slowdown in the economy.

#### Sundaram Securities Services Limited (SSSL)

During the year, Sundaram Securities Services Limited (SSSL) was incorporated as a wholly-owned subsidiary of Sundaram Business Services Limited on 27th June 2008. SSSL entered into a Joint Venture Agreement with BNP Paribas Securities Services (BP2S), a wholly-owned subsidiary of BNP Paribas SA, France, on 03.11.2008, to provide registrar and share transfer agency services (including for mutual funds) and other ancillary securities services in India. Sundaram Finance together with its subsidiaries will hold 51% of the capital while the balance 49% will be held by BP2S.

#### **JOINT VENTURES**

#### Royal Sundaram Alliance Insurance Company Ltd (Royal Sundaram)

In the second full year of the de-tariffed pricing regime, non-life insurance markets witnessed another year of intense competition bringing down the premium rates further.

Against this backdrop, Royal Sundaram registered 16% growth in Gross Written Premium at Rs.803.36 cr. as against Rs. 694.41 cr. in the previous year and earned an investment

income of Rs. 75.56 cr. as against Rs.48.20 cr. in the previous year. The company reported a higher net profit of Rs.5.66 cr. for the year as against Rs. 4.71 cr. in the previous year.

#### BNP Paribas Sundaram Global Securities Operations Private Limited

During the year, SBSL has invested Rs. 46.31 lakhs representing 49% in the paid-up capital of BNP Paribas Sundaram Global Securities Operations Private Limited, which acts as the business process offshoring centre of BNP Paribas Securities Services in Asia.

#### **DIRECTORS**

Sri S Padmanabhan, a Director of your Company since 1989, passed away on 12th February 2009. He was also the Chairman of the Audit Committee, Share Transfer & Investor Relations Committee and Compensation Committee. Your directors wish to place on record the immense contribution made and guidance given by him to the deliberations of the Board and all its Committees for over two decades.

Sri A. Rangaswami, an independent director of your Company, was appointed as Chairman of the Audit Committee and Share Transfer & Investor Relations Committee on 27th February 2009.

Sri S. Ravindran, Sri S. Prasad and Sri Aroon Raman were co-opted as independent directors during the year 2008-09, taking the strength of independent directors to fifty percent. Sri S. Ravindran was also inducted into the Audit Committee and appointed as Chairman of the Compensation Committee. Sri S. Prasad was inducted into the Audit Committee and Share Transfer & Investor Relations Committee.

Sri S Narayanan and Sri Srinivas Acharya retire by rotation and, being eligible, offer themselves for re-election. Under Section 260 of the Companies Act, 1956, Sri S. Ravindran, Sri S. Prasad and Sri Aroon Raman hold office up to the date of the ensuing Annual General Meeting. The Company has received due notices from some members, proposing their appointment as directors of the Company. Necessary resolutions are submitted for your approval.

#### **AUDITORS**

M/s Brahmayya & Co., Chartered Accountants, Chennai, retire and are eligible for re-appointment. A certificate under Section 224(1B) of the Companies Act, 1956 has been received from them.



#### 17. NOTES TO THE ACCOUNTS

#### 1 SIGNIFICANT ACCOUNTING POLICIES

1.1 The financial statements are prepared and presented under the historical cost convention on the accrual basis of accounting and comply with the provisions of the Companies Act, 1956. Besides, the Company follows the directions prescribed by the Reserve Bank of India (RBI) for Non Banking Financial Companies.

The preparation of the financial statements in conformity with generally accepted accounting principles requires the use of estimates and assumptions that affect the reported amount of assets and liabilities as at the Balance Sheet date, reported amounts of revenues and expenses during the year and disclosure of contingent liabilities as at that date. The estimates and assumptions used in these financial statements are based upon the management's evaluation of the relevant facts and circumstances as of the date of the financial statements.

#### 1.2 Income recognition:

- a) Income from Hypothecation Loans and Hire Purchase transactions is accounted on the basis of the Internal Rate of Return method.
- b) Lease income is accounted as per the terms of the lease agreements for contracts entered into upto 31st March 2001. Income from leases entered into on or after 1st April, 2001 is accounted as per Accounting Standard AS 19 Leases.
- c) Income from Services is recognised on accrual basis.

#### 1.3 Fixed Assets and Depreciation / Amortisation:

Fixed Assets are stated at historical cost less accumulated depreciation.

Depreciation on assets is provided on the Written Down Value method at rates prescribed in Schedule XIV to the Companies Act, 1956. Assets costing Rs.5000 or less acquired during the year are fully depreciated.

Cost of assets given on lease is amortised during the lease period for all leased assets acquired prior to 01-04-2001, as recommended in the "Guidance Note on Accounting for Leases (Revised)". Lease Equalisation Account, which represents the excess/shortfall of annual lease charge when compared with statutory depreciation, is recognised. The value of assets on Finance Lease is further adjusted for balance in Lease Adjustment Account.

#### 1.4 Valuation of Investments:

Long-term investments are stated at cost and provision for diminution in value, other than temporary, is considered wherever necessary.

Current investments are valued at lower of cost and market value/net asset value.

#### 1.5 Foreign Currency Transactions:

Transactions in foreign currencies are accounted at the prevailing rates of exchange on the date(s) of the transaction.

Monetary items denominated in foreign currencies are restated at the prevailing rates of exchange at the Balance Sheet date. Gain or loss arising out of fluctuations in exchange rates are accounted for in the Profit and Loss Account.

Exchange differences on forward exchange contracts, entered into for hedging foreign exchange fluctuation risk in respect of asset/liability are recognised in the Profit and Loss Account in the reporting period in which the exchange rate changes. Premium on forward exchange contracts is expensed over the tenure of the contract.

Interest accrued on secured / unsecured foreign currency loans which are covered by forward contracts, has been provided at the forward exchange contract rate and on loans not so covered at the exchange rate prevailing at the year-end.



#### 17. NOTES TO THE ACCOUNTS (Contd.)

#### 1.6 Employee Benefits:

#### A) Short Term Employee Benefits:

Short Term Employee Benefits for services rendered by employees are recognized during the period when the services are rendered.

#### B) Post employment benefits:

#### **Defined Contribution Plan**

#### i) Provident Fund

Contributions are made to the Company's Employees Provident Fund Trust in accordance with the fund rules. The interest rate payable by the trust to the beneficiaries every year is notified by the Government. The Company has an obligation to make good the shortfall, if any, between the return from the investment of the trust and the notified interest rate.

The Company also contributes to a government administered Employees Pension Scheme under the Employees Provident Fund Act and to Employees' State Insurance Schemes on behalf of its employees.

#### ii) Superannuation

The Company makes fixed contributions as a percentage on salary to the superannuation fund, which is administered by trustees and managed by the Life Insurance Corporation of India (LIC).

The above contributions are charged to the Profit and Loss Account.

#### **Defined Benefit Plan**

#### i) Gratuity

The Company makes an annual contribution to a Gratuity Fund administered by trustees and managed by LIC and SBI Life Insurance Company Limited (SBI Life). The Company accounts its liability based on an actuarial valuation, as at the balance sheet date, determined every year by LIC and SBI Life using the Projected Unit Credit method.

#### ii) Leave Encashment

Liability on account of encashment of leave to employees is provided on the basis of an actuarial valuation.

The expenses and actuarial gain / loss on account of the above benefit plans are recognised in the profit and loss account on the basis of an actuarial valuation.

#### C) Other Long Term Employee Benefits:

The estimated liability in respect of other long term benefits like Employee Assured Bonus Scheme, reimbursement of medical expenses and entitlement of sick leave has been provided on the basis of actuarial valuation.

#### 1.7 Taxation:

Current tax is provided on the taxable income for the year.

Deferred tax liabilities arising from timing differences have been fully provided for. Deferred tax assets are recognised on the consideration of prudence.

#### 1.8 Intangible Assets:

Items of computer software acquired / developed are recorded as intangible assets and their cost is amortised over their expected useful life.

### 1.9 Impairment of Assets:

The carrying amounts of assets are reviewed at each balance sheet date to ascertain impairment based on internal / external factors. An impairment loss is recognised when the carrying amount of an asset exceeds its recoverable amount. The recoverable amount is the higher of the net selling price of the assets and their value in use.

#### 17. NOTES TO THE ACCOUNTS (Contd.)

#### 1.10 Provisions:

Provisions are recognised when the Company has present legal or constructive obligations, as a result of past events, for which it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made for the amount of the obligation.

The Special Reserve has been created in terms of the Rupee Term Loan agreement entered into with International Finance Corporation, Washington and is not distributable during the subsistence of the loan.





#### 17 NOTES TO THE CONSOLIDATED FINANCIAL STATEMENTS

#### 1.1 SIGNIFICANT ACCOUNTING POLICIES

1.1.1 The parent company Sundaram Finance Limited follows the directions prescribed by the Reserve Bank of India for Non-Banking Financial Companies, while the subsidiary, Sundaram BNP Paribas Home Finance Limited and Joint Venture Royal Sundaram Alliance Insurance Company Limited follow the directions prescribed by the National Housing Bank for Housing Finance Companies and the Insurance Regulatory and Development Authority respectively.

The financial statements of the associate Dunes Oman LLC(FZC) have been prepared in accordance with International Financial Reporting Standards (IFRS) issued by the International Accounting Standards Board (IASB).

The preparation of the financial statements in conformity with generally accepted accounting principles requires the use of estimates and assumptions that affect the reported amount of assets and liabilities as at the Balance Sheet date, reported amounts of revenues and expenses during the year and disclosure of contingent liabilities as at that date. The estimates and assumptions used in these financial statements are based upon the management's evaluation of the relevant facts and circumstances as of the date of the financial statements.

#### 1.1.2 Income Recognition:

- a) Income from Hypothecation loan transactions, Hire Purchase and Housing Finance loan transactions is accounted on the basis of the Internal Rate of Return method.
- b) Lease income is accounted as per the terms of the lease agreements for contracts entered into upto 31st March 2001. Income from leases entered into on or after 1st April, 2001 is accounted as per the Accounting Standard AS 19 Leases.
- c) Income from Services is recognised on accrual basis.
- d) Premium from Insurance business is recognised as income over the contract period or period of risk, as appropriate, after adjusting for unearned premium (unexpired risk) and premium deficiency, if any.
- e) Trusteeship fee, Investment management and advisory fee are accounted on accrual basis.
- f) Sales of Products are recorded when significant risks and rewards of ownership of products are passed on to the customers. Sales are stated at contractual realisable values net of value added tax and inclusive of resale sales tax and trade discounts and returns if any.

Revenues from software development, which are generally time bound fixed price are recognised over the life of the contract using the proportionate completion method, with contract cost determining the degree of completion.

Revenue from other services is recognised as income on completion.

#### 1.1.3 Fixed Assets and Depreciation / Amortisation:

Fixed assets are stated at historical cost less accumulated depreciation.

Depreciation on assets is provided on the Written Down Value Method at rates prescribed in Schedule XIV to the Companies Act, 1956. Assets costing Rs. 5000 or less acquired during the year are fully depreciated.

Cost of assets given on lease is amortised during the lease period for all leased assets acquired prior to 01.04.2001, as recommended in the "Guidance Note on Accounting for Leases (Revised)". Lease Equalisation Account, which represents the excess/shortfall of annual lease charge when compared with statutory depreciation, is recognised. The Value of assets on Finance Lease is further adjusted for balance in Lease Adjustment Account.

Cost of assets taken on lease on or after 1st April, 2001 is amortised over the lease tenure as per the Accounting Standard — AS 19 — Leases, based on the capital recovery method.

#### 17 NOTES TO THE CONSOLIDATED FINANCIAL STATEMENTS (Contd.)

#### 1.1.4 Valuation of Investments:

Long-term investments are stated at cost and provision for diminution in value, other than temporary, has been considered wherever necessary.

Current investments are valued at lower of cost and market value/ net asset value.

#### 1.1.5 Foreign Currency Transactions:

Transactions in foreign currencies are accounted at the prevailing rates of exchange on the date(s) of the transaction.

Monetary items denominated in foreign currencies are restated at the prevailing rates of exchange at the Balance Sheet date. Gain or Loss arising out of fluctuations in exchange rates are accounted for in the Profit and Loss Account.

Exchange differences on forward exchange contracts, entered into for hedging foreign exchange fluctuation risk in respect of asset / liability are recognised in the Profit and Loss Account in the reporting period in which the exchange rate changes. Premium on forward exchange contracts is expensed over the tenure of the contract.

Interest accrued on secured / unsecured foreign currency loans which are covered by forward contracts has been provided at the forward exchange contract rate and on loans not so covered at the exchange rate prevailing at the year-end.

## 1.1.6 Employee Benefits:

#### a) Short Term Employee Benefits:

Short Term Employee Benefits for services rendered by employees are recognized during the period when the services are rendered.

### **B)** Post employment benefits:

**Defined Contribution Plan** 

#### (i) Provident Fund

Contributions are made to the Company's Employees Provident Fund Trust in accordance with the fund rules. The interest rate payable by the trust to the beneficiaries every year is notified by the Government. The Company has an obligation to make good the shortfall, if any, between the return from the investment of the trust and the notified interest rate.

The Company also contributes to a government administered Employees Pension Scheme under the Employees Provident Fund Act and to Employees' State Insurance Schemes on behalf of its employees.

#### (ii) Superannuation

The Company makes fixed contributions as a percentage on salary to the superannuation fund, which is administered by trustees and managed by the Life Insurance Corporation of India (LIC).

The above contributions are charged to the Profit and Loss Account.

#### Defined Benefit Plan

#### (i) Gratuity

The Company makes an annual contribution to a Gratuity Fund administered by trustees and managed by LIC and SBI Life Insurance Company Limited (SBI Life). The Company accounts its liability based on an actuarial valuation, as at the balance sheet date, determined every year by LIC and SBI Life using the Projected Unit Credit method.

#### (ii) Leave Encashment

Liability on account of encashment of leave to employees is provided on the basis of an actuarial valuation.

The expenses and actuarial gain / loss on account of the above benefit plans are recognised in the profit and loss account on the basis of an actuarial valuation.

#### **C) Other Long Term Employee Benefits:**

The estimated liability in respect of other long term benefits like Employee Assured Bonus Scheme, reimbursement of medical expenses and entitlement of sick leave has been provided on the basis of actuarial valuation.

#### 1.1.7 Taxation:

Current tax is provided on the taxable income for the year.

Deferred tax liabilities arising from timing differences have been fully provided for. Deferred tax assets are recognised on the consideration of prudence.

#### 1.1.8 Intangible Assets:

Items of computer software acquired / developed are recorded as intangible assets and their cost is amortised over their expected useful life.

#### 1.1.9 Impairment of Assets:

The carrying amounts of assets are reviewed at each balance sheet date to ascertain impairment based on internal / external factors. An impairment loss is recognised when the carrying amount of an asset exceeds its recoverable amount. The recoverable amount is the higher of the net selling price of the assets and their value in use.

#### 1.1.10 Provisions:

Provisions are recognised when the Company has present legal or constructive obligations, as a result of past events, for which it is probable that an outflow of economic benefits will be required to settle the obligation and a reliable estimate can be made for the amount of the obligation.

#### 1.2 Basis of Presentation:

The financial statements have been prepared and presented under the historical cost convention on the accrual basis of accounting and comply with the relevant provisions of the Companies Act, 1956.

# Auditors' Report to the Board of Directors of Sundaram Finance Limited on the Consolidated Financial Statements

We have examined the attached Consolidated Balance Sheet of Sundaram Finance Limited, Chennai, its subsidiaries and associate companies as at 31st March 2009, the Consolidated Profit and Loss Account for the year ended on that date and the Consolidated Cash Flow Statement for the year ended on that date annexed thereto which we have signed under reference to this report. These financial statements are the responsibility of the management of Sundaram Finance Limited. Our responsibility is to express an opinion on these financial statements, based on our audit.

We conducted our audit in accordance with generally accepted auditing standards in India. These Standards require that we plan and perform the audit to obtain reasonable assurance whether the financial statements are prepared, in all material respects, in accordance with an identified financial reporting framework and are free of material misstatements. An audit includes, examining on a test basis, evidence supporting the amounts and disclosures in the financial statements. An audit also includes assessing the accounting principles used and significant estimates made by management, as well as evaluating the overall financial statements. We believe that our audit provides a reasonable basis for our opinion.

The financial statements of two subsidiary companies, one joint venture company and one associate company reflecting total assets of Rs.113835.40 lakhs as at 31st March 2009, total revenue of Rs.74315.75 lakhs and net cash inflows amounting to Rs.5420.54 lakhs for the year ended on that date, the financial statements of an associate company reflecting total assets of Rs.957.84 lakhs as at 31st December 2008 and total revenue of Rs.1399.05 lakhs for the year ended on that date have been audited by other auditors, whose reports have been furnished to us.
