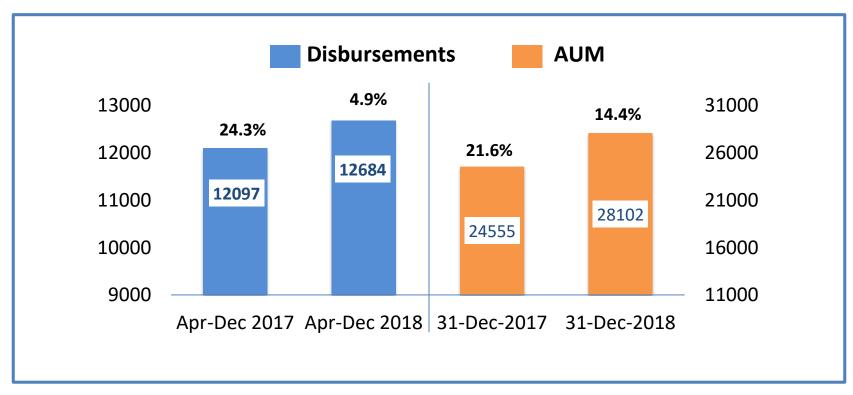

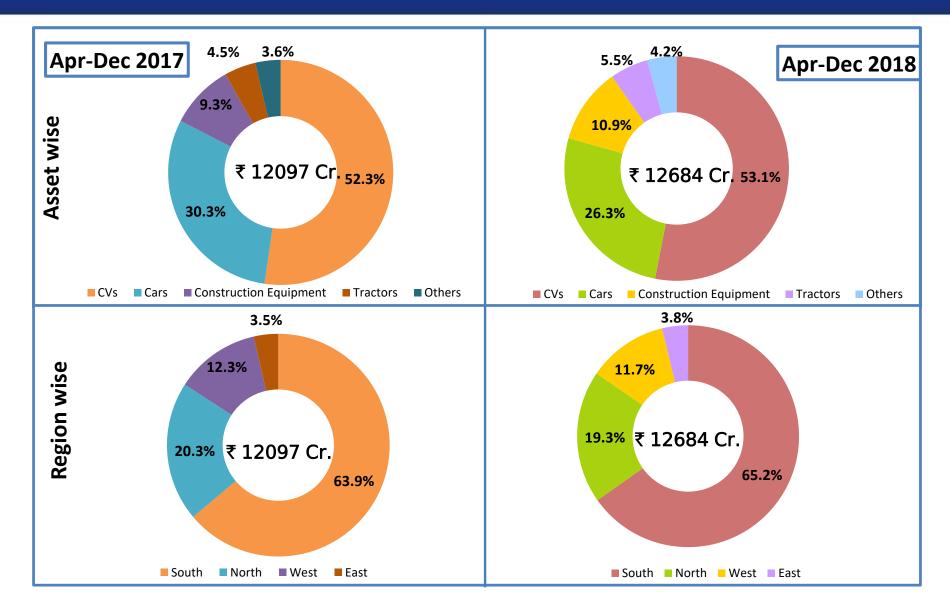
Disbursements and AUM



AUM - Assets Under Management

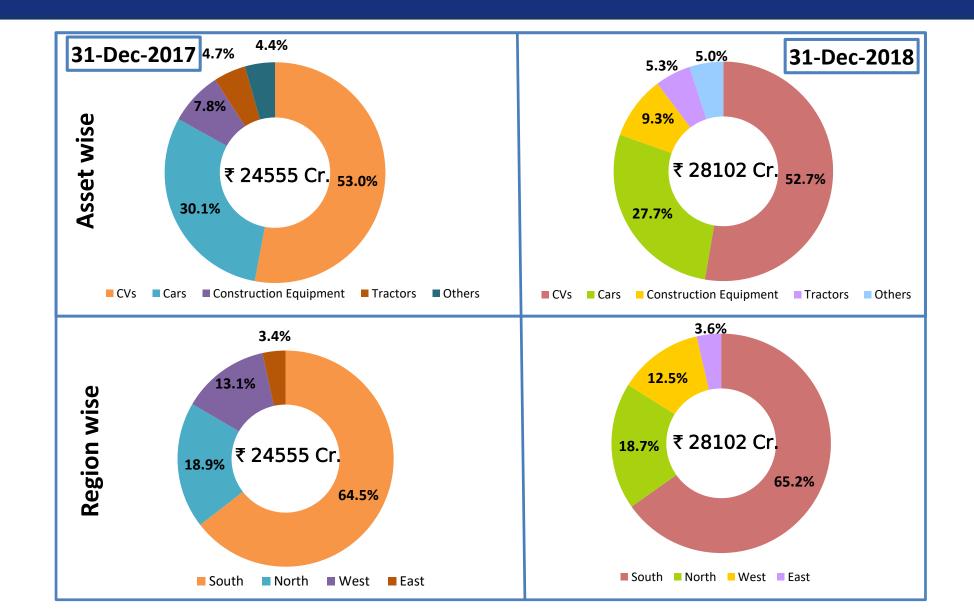

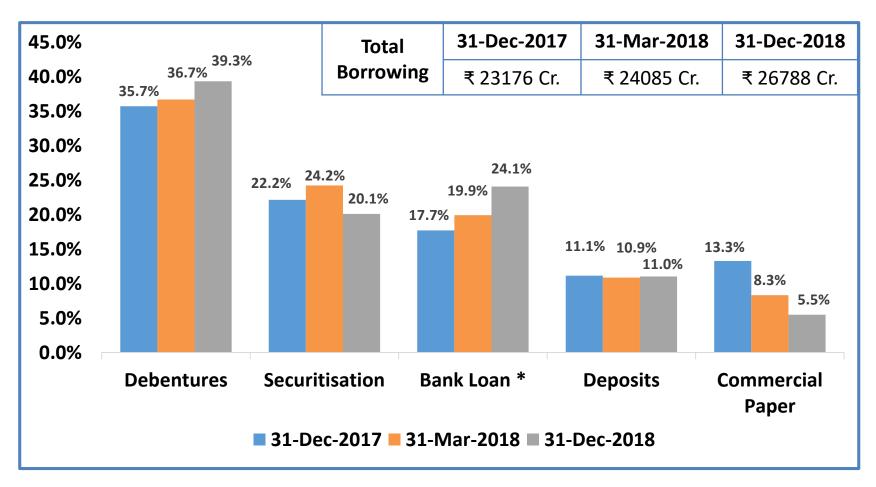

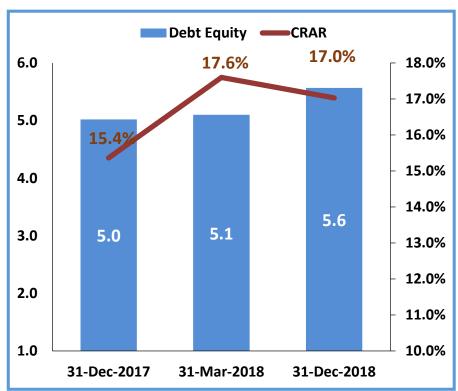

Key Ratios



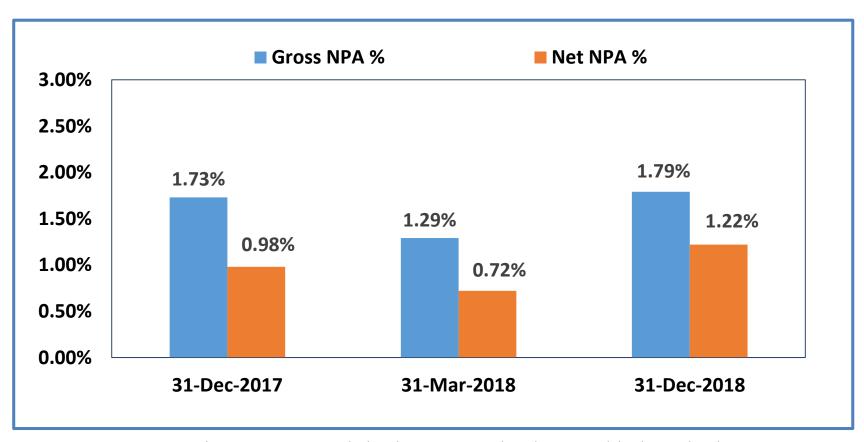

Portfolio Quality

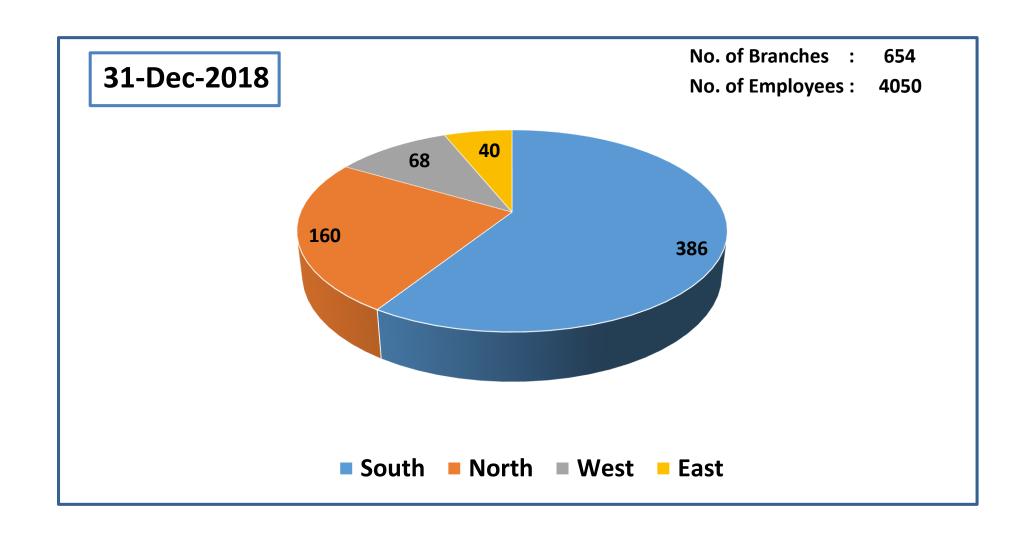




Gross & Net NPA corresponds to stage 3 assets, calculated as per Expected Credit Loss model in line with Ind AS.
